These services include campaign pledge processing, accounting and technology hosting. These services allow the local United Ways to decrease staffing levels and provide tools to effectively manage their resources.

Membership Services - Membership services is the core of Indiana United Ways as it works closely with its 47 local United Way members. IUW provides resources and tools to support its members and opportunities for the members to network and share information and best practices. IUW also provides training for Board and staff and executive coaching. Additionally, collaboration and merger discussions are facilitated and assistance is given in aligning impact work among the members.

Indiana United Ways provides matching grant money to fund impact projects in local communities. In 2021, Indiana United Way awarded 44 grants of almost \$15 million to Indiana communities through local United Ways and agencies from the COVID-19 Economic Relief Initiative that was funded by the Lilly Endowment Inc.
